### **GENERAL SUMMARY**

To provide safe and timely transportation for the Sisters. Behavior will reflect the Mission of the Sisters of St. Francis to ensure a homelike quality of life for the Sisters assuring confidentiality at all times with issues relating to residents, guests and fellow employees.

## **ESSENTIAL FUNCTIONS**

- Responsible for safely driving the Assisi Heights taxi/van to Clinic and other predetermined destinations on a daily time schedule
- Monitors the daily schedule, utilizing taxi/van according to number of passengers
- Follows all road safety rules and regulations, including laws regarding cell phone usage
- Provides assistance to Sisters with getting in and out of the taxi/van
- Complete unscheduled taxi/van runs to locations for Sister's needs, upon approval of the Director of Residential Life
- Monitoring riders in the taxi/van, insuring that it is an authorized rider, if they are not an authorized rider referring them to the Director of Residential Life for correct authorization
- Complete daily monetary drops at banks as requested by the Business Office
- Takes responsibility to clean and care for vehicles
- Follows established dress code positively representing the Sisters of St. Francis
- Identify and communicate concerns regarding taxi/van car maintenance to the Maintenance staff when necessary

### **OTHER FUNCTIONS**

- Completes occasional errands for Assisi Heights Sisters as approved by the Director of Residential Life.
- Fills in for other departments during downtime
- Other duties as assigned by the Director of Residential Life.
